This Letter of Offer also contains forward-looking statements that involve risks, assumptions, estimates and uncertainties. Our actual results could differ materially from those anticipated in these forward-looking statements as a result of certain factors, including the considerations described below and elsewhere in this Letter of Offer.

RISKS MATERIAL TO OUR COMPANY AND ITS BUSINESS

- We had negative cash flow in recent fiscals and may continue to experience negative cash flows in the future, which could adversely impact our business, financial condition and results of operations.***

Our company has experienced negative cash flows in the recent fiscals. The detailed break up of cash flows is summarized in below mentioned table:

There can be no assurance that our net cash flows shall be positive in the future. Any negative cash flows in the future over extended periods, or significant negative cash flows in the short term, could materially impact our ability to operate our business and implement our growth plans. As a result, our cash flows, business, future financial performance and results of operations could be materially and adversely affected.

- Our Company is dependent on limited number of suppliers for procurement of components used in manufacture of our products. Any disruption, delay or by suppliers, may materially and adversely affect our business, financial condition and results of operations.***

Our Company manufactures Speed Limiting Devices and Vehicle Tracking Devices and relies on various domestic suppliers for the procurement of components and materials required in the manufacturing process. The timely availability of these components is critical to our production schedules and ability to fulfil customer orders. Any delay, disruption or failure by our suppliers to provide components in the required quantities, quality standards or within stipulated timelines could result in production delays, increased costs, inability to meet customer requirements and loss of business opportunities.

Further, our purchases are concentrated among a limited number of suppliers. Our top 10 suppliers accounted for purchases aggregating to ₹1,801.66 lakhs, representing 84.42% of our total purchases in Fiscal 2026, and ₹1,222.09 lakhs, representing 86.56% of our total purchases in Fiscal 2025. Any deterioration in the financial condition, operational capabilities or business prospects of these suppliers may impair their ability to meet our procurement requirements. In addition, our suppliers are exposed to risks such as supply chain disruptions, labour shortages, transportation constraints, inflation, fluctuations in raw material prices, regulatory changes, geopolitical tensions, natural disasters and other unforeseen events, which may affect the availability and pricing of components.

While we seek to maintain relationships with multiple suppliers, there can be no assurance that alternative sources of supply would be available on commercially acceptable terms or within the required time frame. Any significant

disruption in the supply of components may adversely affect our manufacturing operations, profitability, cash flows, reputation and results of operations.

3. *Substantial portion of our revenue is derived from a limited number of customers. The loss of, or a significant reduction in business from, any of these customers could adversely affect our business, financial condition and results of operations.*

Our Company manufactures and sells Speed Limiting Devices and Vehicle Tracking Devices and derives a significant portion of its revenue from a limited number of customers. During Fiscal 2026 and Fiscal 2025, our top 10 customers contributed revenue aggregating to ₹ 1,981.83 lakhs and ₹1,369.75 lakhs, respectively, representing 82.70% and 90.45% of our total turnover for the respective periods. Such concentration increases our dependence on a relatively small customer base and exposes us to customer concentration risk.

We do not have contractual arrangements with our customers and our revenues are dependent upon continued orders from such customers. Our ability to maintain and grow our revenues depends on our continued relationships with these customers, which may be affected by factors beyond our control, including changes in their business requirements, procurement policies, financial condition, operational performance, competitive pressures, regulatory developments and general economic conditions. There can be no assurance that our existing customers will continue to place orders with us at historical levels or at all. Any reduction in demand, cancellation or delay of orders, loss of a significant customer, adverse changes in customer procurement decisions or shift to alternative products or service providers could materially and adversely affect our revenues and profitability.

Further, any deterioration in the financial condition of our major customers may adversely impact their ability to make timely payments, resulting in increased receivables, higher credit risk and pressure on our working capital requirements. If we are unable to retain our existing key customers, diversify our customer base or secure additional orders from new and existing customers, our business, financial condition, cash flows and results of operations could be materially and adversely affected.

4. *A substantial portion of our revenue is generated from a limited number of states, and any adverse developments in these regions could materially and adversely affect our business, financial condition and results of operations.*

A significant portion of our revenue is derived from customers located in a limited number of states in India. During Fiscal 2026, Delhi, Haryana and Telangana collectively contributed ₹1,776.42 lakhs, representing 74.13% of our total turnover. During Fiscal 2025, these states collectively contributed ₹1,124.32 lakhs, representing 73.26% of our total turnover. Accordingly, our business is exposed to risks associated with economic slowdowns, changes in government policies, regulatory developments, political instability, natural disasters, disruptions in transportation and logistics, labour shortages, or other adverse events affecting these regions.

Any reduction in demand for our products or services, loss of customers, delay or cancellation of orders, increased competition or disruption in operations in these states may adversely impact our revenue and profitability. In addition, any adverse changes in the regulatory framework governing the automobile safety, tracking or telematics industry in these regions may impact our operations and future growth prospects.

While we continue to explore opportunities to expand our geographical presence, there can be no assurance that we will be able to successfully diversify our revenue base across other states or replace any loss of business from these regions in a timely manner. Consequently, any significant adverse change in the economic, regulatory or business environment in the states from which we derive a substantial portion of our revenue could materially and adversely affect our business, financial condition, cash flows and results of operations.

5. *Our revenue is substantially dependent on the sale of Vehicle Location Tracking Devices. Any reduction in demand for, or sales of, Vehicle Location Tracking Devices may adversely affect our business, financial condition and results of operations.*

Our Company derives a substantial portion of its revenue from the sale of Vehicle Location Tracking Devices (VLTDs). During Fiscal 2026 and Fiscal 2025, revenue from the sale of VLTDs amounted to ₹2,367.78 lakhs and ₹1,331.52 lakhs, respectively, representing 98.81% and 86.76% of our total turnover for the respective periods. As a result, our business is significantly dependent on the continued demand for and acceptance of VLTDs in the market.

The demand for VLTDs is influenced by various factors, including regulatory requirements, technological advancements, customer preferences, competition, pricing pressures, government policies relating to vehicle safety

and tracking systems, and overall economic conditions. Any reduction in demand for VLTDs, emergence of alternative technologies, adverse regulatory changes, increased competition or inability to adapt to changing customer requirements may adversely affect our sales and profitability.

Further, our dependence on a single product category limits our ability to offset any decline in VLTD sales through revenue generated from other products and services. Revenue from Speed Limiting Devices and E-SIM services contributed only 1.04% and 0.16%, respectively, of our total turnover in Fiscal 2026. Consequently, any significant decline in the sale of Vehicle Location Tracking Devices could have a material adverse effect on our business, financial condition, cash flows and results of operations.

6. *A substantial portion of our revenue is derived from our manufacturing activities. Any disruption in our manufacturing operations may adversely affect our business, financial condition and results of operations.*

Our Company primarily derives its revenue from the manufacturing and sale of its products. During Fiscal 2026 and Fiscal 2025, revenue from manufacturing activities amounted to ₹2,392.58 lakhs and ₹1,437.85 lakhs, respectively, representing 99.84% and 93.69% of our total turnover for the respective periods. As a result, our business and profitability are significantly dependent on the continued and efficient operation of our manufacturing activities.

Our manufacturing operations are subject to various risks, including interruption in the supply of raw materials and components, equipment breakdowns, power shortages, labour disputes, accidents, natural disasters, regulatory changes, quality control issues and other unforeseen events. Any disruption or slowdown in our manufacturing processes may adversely affect our ability to meet customer requirements and fulfil orders in a timely manner, which could result in loss of customers, reduced revenues and damage to our reputation.

Further, revenue from services contributed only ₹3.73 lakhs and ₹96.88 lakhs, representing 0.16% and 6.31% of our total turnover in Fiscal 2026 and Fiscal 2025, respectively. Consequently, any material disruption in our manufacturing activities may not be offset by revenues from other business activities. If we are unable to maintain the efficiency and continuity of our manufacturing operations, our business, financial condition, cash flows and results of operations could be materially and adversely affected.

7. *Our revenue is predominantly derived from domestic sales and any adverse developments affecting the domestic market may materially and adversely affect our business, financial condition and results of operations.*

Our Company derives substantially all of its revenue from domestic sales. During Fiscal 2026 and Fiscal 2025, revenue from domestic operations amounted to ₹2,368.48 lakhs and ₹1,534.58 lakhs, respectively, representing 98.84% and 99.99% of our total turnover for the respective periods. In comparison, revenue from exports contributed only ₹27.83 lakhs and ₹0.15 lakhs, representing 1.16% and 0.01% of our total turnover during Fiscal 2026 and Fiscal 2025, respectively. Accordingly, our business is highly dependent on the demand for our products within the Indian market.

Our operating performance is therefore significantly influenced by domestic economic conditions, industry growth, government policies, regulatory requirements relating to vehicle safety and tracking systems, changes in customer preferences, competitive pressures and overall business sentiment in India. Any slowdown in economic activity, reduction in customer spending, adverse regulatory changes, increase in competition or other unfavorable developments affecting the domestic market could result in reduced demand for our products and adversely impact our revenues and profitability.

Further, our limited contribution from export sales restricts our ability to offset any decline in domestic demand through revenues generated from international markets. If we are unable to expand our geographical reach or diversify our revenue sources, any significant adverse development in the domestic market could materially and adversely affect our business, financial condition, cash flows and results of operations.

8. *Our technology infrastructure is critical to our business operations and growth prospects, and failure to improve or effectively utilise our technology infrastructure or prevent disruptions to our technology infrastructure could harm our business operations, reputation and growth prospects.*

Our business is technology driven and relies extensively on our technology infrastructure, software applications and information technology systems for the development, manufacturing and delivery of our products and services. We utilize technology across various functions, including vehicle tracking, real-time monitoring, customer order management, production planning, manufacturing processes, inventory management, procurement and financial

accounting. Accordingly, the reliability, availability and performance of our technology systems are critical to our business operations.

The technology industry is characterized by rapid advancements and evolving customer requirements. Any failure to upgrade or adapt our technology infrastructure and products to changing market conditions may result in technological obsolescence and reduced competitiveness. Further, our systems may be vulnerable to software defects, hardware failures, cyber-attacks, data breaches, network disruptions, power outages and other unforeseen events. Any such disruption may adversely affect our operations, customer service capabilities and product performance.

Further, any errors, bugs or malfunctions in our technology systems could disrupt our operations, impair our ability to provide services to customers and adversely affect customer satisfaction. Consequently, any failure to effectively maintain, protect or enhance our technology infrastructure could materially and adversely affect our business, reputation, financial condition and results of operations.

9. Our business is subject to various government regulations, approvals, certifications and compliance requirements. Any failure to obtain, maintain or renew the necessary approvals, licenses and certifications, or any changes in the regulatory framework, could adversely affect our business, financial condition and results of operations.

Our business operates in a regulated environment and is subject to various central and state laws, including those relating to the automobile industry, product standards, manufacturing operations, labour laws and commercial activities. Our products require approvals and certifications from regulatory authorities such as ICAT and ARAI, and we are required to obtain, maintain and renew various statutory licenses, registrations and approvals for our operations.

Any failure to obtain, maintain or renew such approvals, or any non-compliance with applicable laws or regulatory conditions, may result in penalties, fines, suspension or cancellation of licenses, regulatory actions or operational disruptions. Further, changes in government policies, laws or regulatory frameworks may require us to incur additional costs, modify our business processes or obtain new approvals. Any regulatory investigation, inspection or enforcement action may also result in increased compliance costs, diversion of management attention and interruption of our business activities. Consequently, any such adverse regulatory developments could materially and adversely affect our business, financial condition, results of operations and growth prospects.

10. Our Company does not maintain an executable order book in the ordinary course of its business.

Our Company is engaged in the supply of Vehicle Location Tracking Devices (“VLTD”), Speed Limiting Devices (“SLD”) and allied products. Unlike project-based businesses, where long-term contracts result in an executable order book representing future revenue to be recognized over a period of time, our Company’s business follows a procurement and supply model. Our Company does not maintain an executable order book in the ordinary course of its business. Our Company's business primarily operates through purchase orders and customer procurement requirements, which are generally received and executed within relatively short periods. Accordingly, our Company does not have a conventional executable order book representing future revenues to be recognized over a period of time.

The projected turnover for Financial Year 2026-27 has been prepared by the management based on various assumptions and factors, including historical operating performance, prevailing regulatory developments, expected market demand, existing customer relationships, repeat business, empanelment with various State authorities, available business opportunities, supply capacity and execution capabilities. However, these projections are not supported by any existing executable order book.

There can be no assurance that the assumptions underlying the projected financial information will materialize or that anticipated purchase orders, regulatory implementation, customer demand or business opportunities will occur as expected. Any delay in implementation of regulatory requirements, lower-than-anticipated demand, inability to secure purchase orders or tenders, increased competition, disruptions in procurement or supply chain, or any other adverse business or economic developments may adversely affect our ability to achieve the projected turnover and financial performance. If our Company is unable to achieve the projected turnover or financial performance, the actual results may differ materially from the projections, which could adversely affect our business, financial condition, results of operations and cash flows.

11. We do not have long-term supply arrangements with our suppliers and any disruption in the availability, quality or pricing of raw materials and components may adversely affect our business, financial condition and results of operations.

Our manufacturing operations depend on the timely procurement of various raw materials and components, including enclosures, solenoid valves, hose pipes, electronic components and GPS/IRNSS modules. We primarily source these materials from domestic suppliers and generally procure them based on purchase orders and short-term arrangements rather than long-term supply contracts.

As a result, we are exposed to risks relating to fluctuations in material prices, supply shortages, delays in delivery, quality issues and the discontinuation of supplies by existing vendors. Since certain components used in our products are specifically designed to meet our requirements, identifying and qualifying alternative suppliers may be time-consuming and could lead to disruptions in our production process. Further, our suppliers may not always be able to provide materials in the required quantities, quality or at commercially acceptable prices.

In addition, any delay in payments to suppliers or deterioration in our relationship with them may affect the continuity of supplies and could result in delayed or interrupted deliveries. Any significant increase in procurement costs, inability to secure adequate supplies, or disruption in the supply chain may adversely affect our ability to meet customer requirements, increase operating costs and have a material adverse effect on our business, financial condition and results of operations.

12. Product development involves significant costs, time and uncertainty, and our investments in developing new products and services may not generate anticipated returns.

The development and enhancement of our products requires substantial investment of time, capital and management resources. Such investments are inherently subject to technological, commercial and market-related uncertainties. The success of new products depends on various factors, including technological innovation, changing customer preferences, market acceptance, competitive offerings, pricing, effective marketing and successful execution of our business strategies.

We continue to invest in research, development and product enhancement initiatives to maintain our competitive position and support future growth. However, there can be no assurance that these investments will result in commercially successful products or generate adequate revenues within the expected timeframe, or at all. In addition, revenues and profit margins from newly developed products and services may be lower than anticipated or may not be comparable to those generated by our existing offerings.

Further, during the course of development, we may determine that certain products, technologies or services do not have sufficient commercial viability or strategic value to justify continued investment and may discontinue such projects. Any such decision could result in the loss of resources already invested and the inability to recover development costs. If our product development efforts fail to achieve the desired results, are delayed, or do not generate adequate returns, our business, financial condition, results of operations and growth prospects could be materially and adversely affected.

13. Any defects, performance failures, disruptions or quality issues in our products or services may result in customer claims, product recalls, loss of business and adversely affect our reputation and results of operations.

Our business is dependent on our ability to consistently deliver products and services that meet customer requirements, specifications, and applicable quality standards. While we maintain quality control procedures and testing mechanisms throughout our manufacturing and service delivery processes, there can be no assurance that our products and services will be free from defects, technical failures, performance issues or operational disruptions.

Any defects, failures or non-conformity with customer specifications may result in cancellation of orders, product recalls, warranty claims, delayed payments, litigation, increased costs or loss of future business. Such incidents may also lead to customer dissatisfaction and adversely affect our reputation, financial condition and results of operations.

Further, we are empanelled with various State Transportation Departments and other authorities for the supply of our products. Any quality issues or service deficiencies may result in our dis-empanelment or removal from approved vendor lists, which could significantly reduce our business opportunities and materially and adversely affect our business, financial condition and results of operations.

14. *We may be subject to risks associated with product warranty for our products, which could adversely affect our business, financial condition and results of operations.*

Our Company provides after sale service for its products and offers a free warranty period of one year to end use customers. Thereafter, maintenance and support services are provided on a paid basis through our customer network, with our Company providing back-end technical support to such customers. In addition, periodic calibration of the devices sold by us is required to ensure their continued accuracy, functionality and compliance with applicable standards.

We are subject to risks and costs associated with warranty obligations arising from defects, malfunctions or quality issues in our products during the warranty period. Any such defects may result in warranty claims, repairs, replacement or other corrective actions, leading to additional expenses and operational disruptions. Further, product defects, performance failures or product liability claims may result in adverse publicity, damage to our reputation, loss of customers and increased costs. Any such occurrence could have a material adverse effect on our business, financial condition, cash flows and results of operations.

15. *Any Interruptions, failures or performance issues associated with our technology and infrastructure may harm our business and results of operations.*

Our business depends on the efficient functioning of our technology infrastructure to support the manufacturing, monitoring and servicing of our products and solutions. Our continued growth is dependent, in part, on our ability to deliver products and services to customers in a timely and reliable manner.

Although we have not experienced any material disruptions in the past, our technology infrastructure may be susceptible to outages, system failures, software defects, human errors, capacity constraints, cyber incidents, infrastructure modifications or the implementation of new technologies and functionalities. Such events may disrupt our operations, affect the performance of our products and services, delay customer support activities and adversely impact customer satisfaction.

Further, if we are unable to promptly identify and rectify such issues, adequately address capacity requirements, or effectively upgrade and develop our systems to keep pace with technological advancements and changing business needs, our operational efficiency, business prospects, financial condition and results of operations may be adversely affected.

16. *Changes in technology may render our current technologies obsolete or require us to make substantial capital investments, which could adversely affect our business and financial condition.*

Our business operates in the automobile safety, vehicle tracking and connectivity solutions industry, which is subject to continuous technological developments and evolving regulatory requirements. The technologies used in our Electronic Speed Limiting Devices (SLDs), Vehicle Location Tracking Devices (VLTDs) and E-SIM connectivity solutions may become outdated over time, requiring us to upgrade existing products, develop new solutions or adopt emerging technologies to remain competitive and compliant with applicable standards.

Such upgrades may involve substantial expenditure on research and development, product redesign, testing, certifications, software enhancements and manufacturing processes. There can be no assurance that these investments will achieve the desired results or be accepted by customers. Any failure or delay in adapting to technological changes could adversely affect demand for our products and services, which may have a material adverse effect on our business, financial condition and results of operations.

17. *Our Branch Office's where we operate are not owned by us and any disruption, non-renewal or termination of the related agreements may adversely affect our business operations.*

Our Branch Offices located at Bangalore, Mumbai, Delhi, Gurugram and Balasore are not owned by us. Accordingly, our continued use of these premises is subject to the terms and conditions of the respective lease/rent agreements. We cannot assure that such agreements will be renewed upon expiry or continue to be available on commercially acceptable terms in the future.

In the event that any of these agreements are terminated, not renewed, or become unavailable for any reason, we may be required to relocate the affected office and incur additional costs towards identifying and establishing alternative premises and related infrastructure. Any such relocation may result in temporary disruption of our operations, increased operating expenses and diversion of management resources. Consequently, any inability to

continue operating from these premises on favourable terms could have a material adverse effect on our business, financial condition, cash flows and results of operations.

18. *The trademarks used by our Company are either not registered in the name of the Company or are pending registration, and any inability to secure, maintain or protect our trademark rights may adversely affect our business, brand value and operations.*

Our Company uses various trademarks, including “”, “”, “” and “”, in connection with its business operations. The trademark “CTPL” is registered in the name of Containe Technologies Private Limited and the corresponding change in the name of the registered proprietor following the conversion of the entity into a public limited company has not yet been recorded with the Trademark Registry. Further, the trademark “LIMITS” is not registered in the name of our Company and is currently being used pursuant to No Objection Certificates obtained from our Promoter. In addition, applications for registration of the trademarks “TRANOGO” and “TRANOPRO” have been filed and are presently pending before the Registrar of Trademarks.

There can be no assurance that the pending trademark applications will be successfully registered, that the existing permissions for use of trademarks will continue, or that no third party will challenge our rights to use such trademarks. Any delay in updating trademark records, revocation of permissions, failure to obtain registrations, objections by the Trademark Registry, infringement claims or disputes relating to ownership or usage of our trademarks may require us to incur significant costs for litigation, rebranding, marketing and obtaining alternative registrations. Such events may adversely affect our brand recognition, goodwill, business operations, financial condition and results of operations.

19. *Our success depends heavily upon our Promoters, Directors and KMPs/SMPs for their continuing services, strategic guidance and financial support and the loss of their services could affect our business and operations.*

Our Company's growth and success have been significantly influenced by the experience, industry knowledge, business relationships and strategic guidance of our Promoters and Directors. Our Promoters possess substantial experience in the automotive components and vehicle safety solutions industry and have developed long-standing relationships with customers, suppliers and other stakeholders, which have contributed to the growth and development of our business. They play a key role in formulating business strategies, managing operations and identifying growth opportunities.

Further, our Directors and senior management personnel are actively involved in the day-to-day management and operations of our Company. The loss of the services of any of our Promoters, Directors or other key managerial personnel, whether due to resignation, incapacity or other reasons, could disrupt our operations and adversely affect our ability to execute our business strategies. In addition, our Promoters may continue to be involved in other business ventures and commitments, which could limit the time and attention devoted to our Company.

If we are unable to retain or replace such personnel in a timely manner, our business operations, customer relationships, financial condition, business prospects and results of operations could be materially and adversely affected.

20. *Our Company's insurance coverage may not be adequate to protect us against all potential losses which could adversely affect our business, financial condition and results of operations.*

Our company maintains insurance coverage for certain risks associated with its operations including stock insurance, furniture & fixtures, building and plant & machinery. However, our existing insurance coverage may be insufficient to cover all the risks associated with our business and operations including losses from business interruption.

There can be no assurance that our existing insurance coverage will be sufficient to fully compensate us for all losses or liabilities that may arise. In the event of an uninsured loss, a loss exceeding policy limits, or a loss for which insurance coverage is unavailable or economically impractical, including losses arising from natural disasters or other events beyond our control, we may be required to bear the costs from our own resources. Further, we cannot assure that our insurance policies will continue to be available on commercially acceptable terms or be renewed in a timely manner. Any significant uninsured or underinsured loss, increase in insurance premiums or inability to obtain adequate coverage could have a material adverse effect on our business, financial condition, cash flows and results of operations.

21. *Employee misconduct, errors or fraud could expose us to business risks or losses that could adversely affect our business prospects, results of operations and financial condition.*

Employee misconduct, errors, negligence or frauds could expose us to business risks or losses, including regulatory sanctions, penalties, reputational damage and disruptions to our operations. Such employee misconduct includes breach in security requirements, misappropriation of funds, hiding unauthorized activities, failure to observe our operational standards and processes, and improper use of confidential information.

While we have implemented internal controls and monitoring mechanisms, such measures may not always be effective in preventing or detecting all instances of misconduct, fraud or human error. Any losses arising from such incidents may not be recoverable and could require us to write off the related amounts. In addition, employee errors or negligence may expose us to customer complaints, legal claims, regulatory proceedings or other liabilities.

Any such occurrence could adversely affect our reputation, business prospects, financial condition, cash flows and results of operations.

22. *We have not declared any dividends in the past, and our ability to pay dividends in the future will depend on our future earnings, financial condition and cash flows.*

Since our incorporation, we have not declared any dividends on our Equity Shares. We may continue to retain our earnings, if any, to finance the growth and expansion of our business, meet working capital requirements and support future operations. Consequently, there can be no assurance that we will declare or pay dividends in the foreseeable future.

Any future declaration and payment of dividends will be subject to the discretion of our Board of Directors and shareholders, as applicable, and will depend on various factors, including our profitability, financial condition, cash flows, capital expenditure requirements, working capital needs, business prospects, contractual restrictions and applicable legal requirements.

As a result, investors may need to rely primarily on appreciation in the market price of our Equity Shares for a return on their investment. There can be no assurance that our Equity Shares will appreciate in value or that any dividends will be declared in the future. Accordingly, our inability to pay dividends may adversely affect the market price of our Equity Shares.

RISKS RELATING TO RIGHTS ISSUE AND OBJECTS OF THE ISSUE

23. *A substantial portion of the net proceeds from the rights issue is proposed to be utilized for working capital requirements, and any inefficient deployment or variation in these requirements may adversely affect our liquidity, operations, and financial performance.*

Our Company proposes to utilize approximately ₹1,255.70 lakhs from the Net Proceeds of the Rights Issue towards its working capital requirements. Working capital is required to fund our day-to-day operations, including procurement of raw materials and components, maintenance of inventory levels, extension of credit to customers and meeting other operational expenses and short-term obligations.

The actual working capital requirements of our Company may vary from the estimates disclosed in this Letter of Offer due to changes in business volumes, customer credit periods, supplier terms, market conditions, inflation, regulatory developments and other factors beyond our control. Consequently, the amount and timing of deployment of the Net Proceeds towards working capital may differ from our current estimates.

Further, working capital requirements are inherently dynamic and involve ongoing monitoring and management. Any inefficiency, delay or shortfall in the deployment of funds may adversely affect our liquidity, disrupt business operations and impact our ability to execute our growth strategies. In the event of any funding shortfall, we may be required to raise additional debt or other financing, which may not be available on favourable terms or at all. Any such occurrence could have a material adverse effect on our business, financial condition, cash flows and results of operations.

24. *The Rights Entitlement of Eligible Equity Shareholders holding Equity Shares in physical form may lapse in case they fail to furnish the details of their demat account to the Registrar.*

In accordance with Regulation 77A of the SEBI ICDR Regulations read with the SEBI ICDR Master Circular HO/49/14/14(2)2026-CFD-POD2/I/4518/2026 (*last updated February 09, 2026*) the credit of Rights Entitlements and Allotment of Rights Equity Shares shall be made in dematerialized form only. Prior to the Issue Opening Date, our Company shall credit the Rights Entitlements to the demat accounts of the Eligible Equity Shareholders holding the Equity Shares in dematerialised form.

Our Company has opened a separate demat suspense escrow account (namely, “CONTAINTE TECHNOLOGIES LIMITED SUSPENSE ESCROW DEMAT ACCOUNT”) and would credit Rights Entitlements on the basis of the Equity Shares: (a) held by Eligible Equity Shareholders which are held in physical form as on Record Date; or (b) which are held in the account of the Investor Education and Protection Fund (“IEPF”) authority; or which of the Eligible Equity Shareholder whose demat accounts are frozen or where the Equity Shares are lying in the unclaimed/ suspense escrow account / demat suspense account (including those pursuant to Regulation 39 of the SEBI LODR Regulations) or details of which are unavailable with our Company or with the Registrar on the Record Date or where Equity Shares have been kept in abeyance or where entitlement certificate has been issued or where instruction has been issued for stopping issue or transfer or where letter of confirmation lying in escrow account; or (d) where credit of the Rights Entitlements have returned/reversed/failed for any reason; or (e) where ownership is currently under dispute, including any court or regulatory proceedings or where legal notices have been issued, if any or (f) such other cases where our Company is unable to credit Rights Entitlements for any other reasons.

Our Company shall credit the Rights Entitlements to the Demat Suspense Account on the basis of information available with our Company and to serve the interest of relevant Eligible Equity Shareholders to provide them with a reasonable opportunity to participate in the Issue. The credit of the Rights Entitlements to the Demat Suspense Account by our Company does not create any right in favour of the relevant Eligible Equity Shareholders for transfer of Rights Entitlement to their demat account or to receive any Equity Shares in the Issue.

With respect to the Rights Entitlements credited to the Demat Suspense Account, the Eligible Equity Shareholders are required to provide relevant details / documents as acceptable to our Company or the Registrar (such as applicable regulatory approvals, self-attested PAN and client master sheet of demat account, details/ records confirming the legal and beneficial ownership of their respective Equity Shares, etc.) to our Company or the Registrar no later than two clear Working Days prior to the Issue Closing Date to enable credit of their Rights Entitlements by way of transfer from the Demat Suspense Account to their demat account at least one day before the Issue Closing Date, to enable such Eligible Equity Shareholders to make an application in this Issue, and this communication shall serve as an intimation to such Eligible Equity Shareholders in this regard. In the event that the Eligible Equity Shareholders are not able to provide relevant details to our Company or the Registrar by the end of two clear Working Days prior to the Issue Closing Date, Rights Entitlements credited to the Demat Suspense Account shall lapse and extinguish in due course and such Eligible Equity Shareholder shall not have any claim against our Company and our Company shall not be liable to any such Eligible Equity Shareholder in any form or manner and such lapsing of Rights Entitlement may dilute and adverse impact the interest of certain Eligible Equity Shareholders. For details, please see “*Terms of the Issue*” on page 60.

25. The Eligible Equity Shareholders holding Equity Shares in physical form will have no voting rights in respect of Rights Equity Shares until they provide details of their demat account and Rights Equity Shares are transferred to such demat account from the demat suspense account thereafter.

In accordance with the SEBI ICDR Master Circular HO/49/14/14(2)2026-CFD-POD2/I/4518/2026 (*last updated February 09, 2026*), the credit of Rights Entitlement and Allotment of Equity Shares shall be made in dematerialised form only. Accordingly, the Rights Entitlements of the Physical Shareholders shall be credited in a suspense escrow demat account opened by our Company during the Issue Period. The Physical Shareholders are requested to furnish the details of their demat account to the Registrar no later than two clear Working Days prior to the Issue Closing Date to enable the credit of their Rights Entitlements in their demat accounts at least one day before the Issue Closing Date. The Rights Entitlements of the Physical Shareholders who do not furnish the details of their demat account to the Registrar no later than two clear Working Days prior to the Issue Closing Date, shall lapse. Further, pursuant to a press release dated December 3, 2018 issued by the SEBI, with effect from April 1, 2019, a transfer of listed Equity Shares cannot be processed unless the Equity Shares are held in dematerialized form (except in case of transmission or transposition of Equity Shares). For further information, see “*Terms of the Issue*” on page 60.

26. Applicants to this Issue are not allowed to withdraw their Applications after the Issue Closing Date.

In terms of the SEBI ICDR Regulations, Applicants in this Issue are not allowed to withdraw their Applications after the Issue Closing Date. The Allotment in this Issue and the credit of such Rights Equity Shares to the Applicant’s demat account with its depository participant shall be completed within such period as prescribed under

the applicable laws. There is no assurance, however, that material adverse changes in the international or national monetary, financial, political or economic conditions or other events in the nature of force majeure, material adverse changes in our business, results of operations or financial condition, or other events affecting the Applicant's decision to invest in the Rights Equity Shares, would not arise between the Issue Closing Date and the date of Allotment in this Issue. Occurrence of any such events after the Issue Closing Date could also impact the market price of our Equity Shares. The Applicants shall not have the right to withdraw their applications in the event of any such occurrence. We cannot assure you that the market price of our Equity Shares will not decline below the Issue Price. To the extent the market price for our Equity Shares declines below the Issue Price after the Issue Closing Date, the shareholder will be required to purchase Rights Equity Shares at a price that will be higher than the actual market price for the Equity Shares at that time. Should that occur, the shareholder will suffer an immediate unrealized loss as a result. We may complete the Allotment even if such events may limit the Applicants' ability to sell our Equity Shares after this Issue or cause the trading price of our Equity Shares to decline.

27. Failure to exercise or sell the Rights Entitlements will cause the Rights Entitlements to lapse without compensation and result in a dilution of shareholding.

Rights Entitlements that are not exercised prior to the end of the Issue Closing Date will expire and become null and void, and Eligible Equity Shareholders will not receive any consideration for them. The proportionate ownership and voting interest in our Company of Eligible Equity Shareholders who fail (or are not able) to exercise their Rights Entitlements will be diluted. Even if you elect to sell your unexercised Rights Entitlements, the consideration you receive for them may not be sufficient to fully compensate you for the dilution of your percentage ownership of the equity share capital of our Company that may be caused as a result of the Issue. Renouncees may not be able to apply in case of failure of completion of renunciation through off-market transfer in such a manner that the Rights Entitlements are credited to the demat account of the Renouncees prior to the Issue Closing Date. Further in case, the Rights Entitlements do not get credited in time, in case of On Market Renunciation, such Renouncee will not be able to apply in this Issue with respect to such Rights Entitlements. For details, see "***Terms of the Issue***" on page 60.

28. Our Company will not distribute the Letter of Offer and other Issue related materials to overseas shareholders who have not provided an address in India for service of documents.

We will not distribute the Issue Material to the shareholders who have not provided an address in India for service of documents. The Issue Material will not be distributed to addresses outside India on account of restrictions that apply to circulation of such materials in various overseas jurisdictions. In the case that Eligible Equity Shareholders have provided their valid e-mail address, the Letter of Offer will be sent only to their valid e-mail address and in the case that such Eligible Equity Shareholders have not provided their e-mail address, then the Letter of Offer will be dispatched, on a reasonable effort basis, to the Indian addresses provided by them.

However, the Companies Act, 2013 requires companies to serve documents at any address which may be provided by the members as well as through e-mail. Presently, there is lack of clarity under the Companies Act, 2013 and the rules thereunder with respect to distribution of Issue Material in overseas jurisdictions where such distribution may be prohibited under the applicable laws of such jurisdiction. While our Company will request its shareholders to provide an address in India for the purposes of distribution of Issue Material, our Company cannot assure that the regulator would not adopt a different view with respect to compliance with the Companies Act, 2013 and may subject our Company to fines or penalties.

29. Overseas shareholders may not be able to participate in the Company's future rights offerings or certain other equity issues.

If our Company offers or causes to be offered to holders of its Equity Shares rights to subscribe for additional Equity Shares or any right of any other nature, our Company will have discretion as to the procedure to be followed in making such rights available to overseas holders of the Equity Shares or in disposing of such rights for the benefit of such holders. For instance, our Company may not offer such rights to the holders of Equity Shares who have a registered address in the United States unless: (i) a registration statement is in effect, if a registration statement under the U.S. Securities Act is required in order for the Company to offer such rights to holders and sell the securities represented by such rights; or (ii) the offering and sale of such rights or the underlying securities to such holders are exempt from registration under the provisions of the U.S. Securities Act. Our Company has no obligation to prepare or file any registration statement. Accordingly, shareholders who have a registered address in the United States may be unable to participate in future rights offerings and may experience a dilution in their holdings as a result.

30. *Investors will be subject to market risks until our Equity Shares credited to the investor's demat account are listed and permitted to trade.*

Investors can start trading the Rights Equity Shares Allotted to them only after they have been credited to an investor's demat account, are listed and permitted to trade. Since our Equity Shares are currently traded on the BSE SME, investors will be subject to market risk from the date they pay for the Rights Equity Shares to the date when trading approval is granted for the same. Further, there can be no assurance that the Rights Equity Shares allocated to an investor will be credited to the investor's demat account or that trading in such Equity Shares will commence in a timely manner.

31. *Any future issuance of Equity Shares by our Company or sales of our Equity Shares by any of our Company's significant shareholders may adversely affect the trading price of our Equity Shares.*

Any future issuance of Equity Shares by us could dilute your shareholding. Any such future issuance of our Equity Shares or sales of our Equity Shares by any of our significant shareholders may also adversely affect the trading price of our Equity Shares, and could impact our ability to raise capital through an offering of our securities. We cannot assure you that we will not issue further equity shares or that the shareholders will not dispose of, pledge, or otherwise encumber their equity shares. In addition, any perception by investors that such issuances or sales might occur could also affect the trading price of our Equity Shares.

32. *The Rights Equity Shares may experience price and volume fluctuations.*

The market price of the Rights Equity Shares can be volatile as a result of several factors beyond our control, including volatility in the Indian and global securities markets, our results of operations, the performance of our competitors, developments in the Indian finance and lending sector, changing perceptions in the market about investments in this sector in India, investor perceptions of our future performance, adverse media reports about us or our sector, changes in the estimates of our performance or recommendations by financial analysts, significant developments in India's economic liberalization and deregulation policies, and significant developments in India's fiscal regulations. In addition, the stock exchange may experience significant price and volume fluctuations, which may have a material adverse effect on the market price of the Rights Equity Shares.

General or industry specific market conditions or stock performance or domestic or international macroeconomic and geopolitical factors unrelated to our performance also affect the price of the Rights Equity Shares. In particular, the stock market as a whole recently experienced extreme price and volume fluctuations that have affected the market price of many companies in ways that may have been unrelated to the companies' operating performances. For these reasons, investors should not rely on recent trends to predict future share prices, results of operations or cash flow and financial condition.

33. *No market for the Rights Entitlements may develop and the price of the Rights Entitlements may be volatile.*

No assurance can be given that an active trading market for the Rights Entitlements will develop on the Stock Exchange during the Renunciation Period or that there will be sufficient liquidity in Rights Entitlements trading during this period. The trading price of the Rights Entitlements will not only depend on supply and demand for the Rights Entitlements, which may be affected by factors unrelated to the trading in the Equity Shares, but also on the quoted price of the Equity Shares, amongst others. Factors affecting the volatility of the price of the Equity Shares, as described herein, may magnify the volatility of the trading price of the Rights Entitlements, and a decline in the price of the Equity Shares will have an adverse impact on the trading price of the Rights Entitlements. Since the trading of the Rights Equity Shares will be on a separate segment compared to the Equity Shares on the floor of the Stock Exchange, the trading of Rights Equity Shares may not track the trading of Equity Shares.

34. *Foreign investors are subject to foreign investment restrictions under Indian law that limit our Company's ability to attract foreign investors, which may adversely affect the market price of the Equity Shares.*

Under the foreign exchange regulations currently in force in India, transfers of shares between nonresidents and residents and issuances of shares to non-residents are freely permitted (subject to certain exceptions) if they comply with the requirements specified by the RBI. If such issuances or transfers of shares are not in compliance with such requirements or fall under any of the specified exceptions, then prior approval of the RBI will be required. We have undertaken or recorded such transactions in the past based on a bona fide interpretation of the law. We cannot assure you that our interpretation would be upheld by the Indian regulators. Any change in such interpretation could impact the ability of our Company to attract foreign investors.

In addition, shareholders who seek to convert the Indian Rupee proceeds from a sale of shares in India into foreign currency and repatriate that foreign currency from India will require a no-objection or tax clearance certificate from

the income tax authority. Additionally, the Government of India may impose foreign exchange restrictions in certain emergency situations, including situations where there are sudden fluctuations in interest rates or exchange rates, where the Government of India experiences extreme difficulty in stabilizing the balance of payments, or where there are substantial disturbances in the financial and capital markets in India. These restrictions may require foreign investors to obtain the Government of India's approval before acquiring Indian securities or repatriating the interest or dividends from those securities or the proceeds from the sale of those securities. We cannot assure you that any approval required from the RBI or any other government agency can be obtained on any particular terms, or at all.

35. *Rights of shareholders under Indian law may differ or may be more limited than under the laws of other jurisdictions.*

The Companies Act and rules made thereunder, the rules and regulations issued by SEBI and other regulatory authorities, the Memorandum of Association, and the Articles of Association govern the corporate affairs of our Company. Indian legal principles relating to these matters and the validity of corporate procedures, directors' fiduciary duties and liabilities, and shareholders' rights may differ from those that would apply to a company in another jurisdiction. In accordance with the provisions of the Companies Act the voting rights of an equity shareholder in a company shall be in proportion to the share of a person in the paid-up equity share capital of that company. Further, Section 106(1) of the Companies Act states that the articles of a company may provide that no member shall exercise any voting right in respect of any shares registered in his name on which any calls or other sums presently payable by him have not been paid, or in regard to which the company has exercised any right of lien.

36. *You may be subject to Indian taxes arising out of capital gains on the sale of the Rights Equity Shares.*

Under the current Indian Income Tax provisions, all transactions of purchase and sales of securities on Indian stock exchange are subject to levy of securities transaction tax (STT) which will be collected by respective stock exchange on which the securities are transacted. Accordingly, the Indian Income Tax Act has special capital gains tax provisions for all transactions of purchase and sale of equity shares carried out on the Indian Stock Exchange. Under the current Indian Income Tax provisions, unless specifically exempted, capital gains arising from the sale of equity shares in an Indian company are generally taxable in India.

37. *Investors may be restricted in their ability to exercise pre-emptive rights under Indian law and thereby may suffer future dilution of their ownership position.*

Under the Companies Act, a company having share capital and incorporated in India must offer its holders of equity shares pre-emptive rights to subscribe and pay for a proportionate number of shares to maintain their existing ownership percentages before the issuance of any new equity shares, unless the pre-emptive rights have been waived by adoption of a special resolution by the company. However, if the law of the jurisdiction the investors are in, does not permit them to exercise their pre-emptive rights without our Company filing an offering document or registration statement with the applicable authority in such jurisdiction, the investors will be unable to exercise their pre-emptive rights unless our Company makes such a filing. If we elect not to file a registration statement, the new securities may be issued to a custodian, who may sell the securities for the investor's benefit. The value such custodian receives on the sale of such securities and the related transaction costs cannot be predicted. In addition, to the extent that the investors are unable to exercise pre-emptive rights granted in respect of the Equity Shares held by them, their proportional interest in our Company would be reduced.

EXTERNAL RISK FACTORS

38. *Our business, results of operations and cash flows is substantially affected by prevailing economic, political and other conditions in emerging and global markets.*

The Indian economy and securities markets are influenced by economic, political and market conditions in India and globally, including adverse geopolitical conditions. We are incorporated in India, and a substantial amount of our operations are located in India and overseas. As a result, we are highly dependent on prevailing economic conditions in India and the other emerging and global markets and our results of operations and cash flows are significantly affected by factors influencing the economy in these countries. Factors that may adversely affect the economy, and hence our results of operations and cash flows, may include:

- any increase in interest rates or inflation;
- any exchange rate fluctuations;
- any scarcity of credit or other financing, resulting in an adverse impact on economic conditions and scarcity of financing for our expansions;

- prevailing income conditions among consumers and corporates;
- volatility in, and actual or perceived trends in trading activity on, the relevant market's principal stock exchange;
- changes in tax, trade, fiscal or monetary policies;
- political instability, terrorism or military conflict in the region or globally;
- occurrence of natural or man-made disasters;
- prevailing regional or global economic conditions, including in the relevant country's principal export markets;
- any downgrading of debt rating by a domestic or international rating agency;
- instability in financial markets;
- disruption of supply chain and logistics arrangements; and
- other significant regulatory or economic developments in or affecting India or the emerging and global markets.

In addition, any slowdown or perceived slowdown in the Indian economy or the economy of any emerging and global market, or in specific sectors of such economies, could adversely impact our business, results of operations and financial condition and the price of the Equity Shares.

39. Inflation in India could have an adverse effect on our profitability and if significant, on our financial condition.

Inflation rates in India have been volatile in recent years, and such volatility may continue in the future. India has experienced high inflation in the recent past. Increased inflation can contribute to an increase in interest rates and increased costs to our business, including increased costs of salaries, and other expenses relevant to our business.

High fluctuations in inflation rates may make it more difficult for us to accurately estimate or control our costs. Any increase in inflation in India can increase our expenses, which we may not be able to pass on to our customers, whether entirely or in part, and the same may adversely affect our business and financial condition. In particular, we might not be able to reduce our costs or increase our rates to pass the increase in costs on to our customers. In such case, our business, results of operations, cash flows and financial condition may be adversely affected.

40. Natural calamities, climate change and health epidemics and pandemics such as COVID-19 could adversely affect the economy of countries globally and our business, financial condition and results of operations. In addition, hostilities, terrorist attacks, civil unrest and other acts of violence could adversely affect our business, results of operations and financial condition.

Several countries have experienced natural calamities, such as earthquakes and floods in recent years. Natural calamities could have an adverse impact on the global economy which, in turn, could adversely affect our business, and may damage or destroy our borrowers' assets or projects. Any of these natural calamities could adversely affect our business, results of operations and financial condition. A number of countries in Asia, including India, as well as countries in other parts of the world, are susceptible to contagious diseases and, for example, have had confirmed cases of the highly pathogenic H7N9, H5N1 and H1N1 strains of influenza in birds and swine. In addition, the COVID-19 pandemic, had caused a worldwide health crisis and economic downturn. Any future outbreak of health epidemics may restrict the level of business activity in affected areas, which may, in turn, adversely affect our business.

41. Changing laws, regulations and government policies applicable to our business may adversely affect our operations, financial condition and results of operations.

Our business is subject to various central and state laws, regulations and government policies relating to the sale of agricultural inputs and seeds, taxation, labour and other commercial activities. Any changes in the applicable laws, regulations, licensing requirements or government policies, or changes in their interpretation or implementation by the relevant authorities, may require us to incur additional compliance costs, modify our business practices or obtain additional approvals. Such changes may adversely affect our business operations, financial condition, cash flows and results of operations.

We are also subject to various tax laws, including the Goods and Services Tax regime and other direct and indirect tax regulations. Any amendments to the existing tax framework, changes in tax rates, withdrawal of exemptions or incentives, or adverse interpretation of tax laws by the authorities may increase our tax liabilities, compliance burden and operating costs. In addition, any disputes relating to tax assessments or non-compliance, whether actual or alleged, may result in penalties, interest, litigation and reputational harm.

Further, the application of various Indian laws, rules and regulations, including anti-avoidance and other taxation provisions, remains subject to interpretation by the relevant authorities. Any adverse interpretation, retrospective amendment or introduction of new regulatory requirements could result in increased liabilities, denial of tax benefits, additional compliance obligations or other adverse consequences. Any such developments may have a material adverse effect on our business, financial condition, cash flows and results of operations.

42. *We are subject to regulatory, economic, social and political uncertainties and other factors beyond our control.*

We are incorporated in India and we conduct our corporate affairs and our business in India. Our Equity Shares are listed on BSE SME. Consequently, our business, operations, financial performance and the market price of our Equity Shares will be affected by interest rates, government policies, taxation, social and ethnic instability and other political and economic developments affecting India.

Factors that may adversely affect the Indian economy, and hence our results of operations may include:

- any exchange rate fluctuations, the imposition of currency controls and restrictions on the right to convert or repatriate currency or export assets;
- any scarcity of credit or other financing in India, resulting in an adverse effect on economic conditions in India and scarcity of financing for our expansions;
- prevailing income conditions among Indian customers and Indian corporations;
- epidemic or any other public health in India or in countries in the region or globally, including in India's various neighbouring countries;
- hostile or war like situations with the neighbouring countries;
- macroeconomic factors and central bank regulation, including in relation to interest rates movements which may in turn adversely impact our access to capital and increase our borrowing costs;
- volatility in, and actual or perceived trends in trading activity on, India's principal stock exchange;
- decline in India's foreign exchange reserves which may affect liquidity in the Indian economy;
- downgrading of India's sovereign debt rating by rating agencies; and
- difficulty in developing any necessary partnerships with local businesses on commercially acceptable terms and/or a timely basis.

43. *In the event we undertake future acquisitions, mergers or similar corporate actions, we may potentially be affected by competition law in India and any adverse application or interpretation of the Competition Act could in turn adversely affect our business, results of operations and financial condition.*

The Competition Act, 2002 ("**Competition Act**") was enacted for the purpose of preventing practices that have or are likely to have an adverse effect on competition in India and has mandated the Competition Commission of India to prevent such practices. Under the Competition Act, any arrangement, understanding or action, whether formal or informal, which causes or is likely to cause an appreciable adverse effect on competition ("**AAEC**") is void and attracts substantial penalties.

Further, any agreement among competitors which, directly or indirectly, involves determination of purchase or sale prices, limits or controls production, or shares the market by way of geographical area or number of customers in the relevant market is presumed to have an appreciable adverse effect in the relevant market in India and shall be void. The Competition Act also prohibits abuse of a dominant position by any enterprise. The Competition Commission of India (Procedure in regard to the transaction of business relating to combinations) Regulations ("**Combination Regulations**") require acquisitions of shares, voting rights, assets or control or mergers or amalgamations that cross the prescribed asset and turnover based thresholds to be mandatorily notified to, and pre-approved by, the Competition Commission of India. The Competition Act aims to, among other things, prohibit all agreements and transactions which may have an appreciable adverse effect in India. Consequently, all agreements entered into by us in future could be within the purview of the Competition Act. Further, the Competition Commission of India has extra-territorial powers and can investigate any agreements, abusive conduct or combination occurring outside of India if such agreement, conduct or combination has an appreciable adverse effect in India.

The Competition (Amendment) Act, 2023 ("**Competition Amendment Act**") was notified on April 11, 2023, which amends the Competition Act and gives the CCI additional powers to prevent practices that harm competition and the interests of consumers. These amendments include the introduction of deal value thresholds for assessing whether a merger or acquisition qualifies as a "combination", expedited merger review timelines, codification of the lowest standard of "control" and enhanced penalties for providing false information or a failure to provide

material information. Such amendment to the Competition Act will result in additional costs for compliance, which in turn may adversely affect our business, results of operations, cash flows and prospect.

44. Companies operating in India are subject to a variety of taxes and surcharges.

Tax and other levies imposed by the central and state governments in India that affect our tax liability include central and state taxes and other levies, income tax, value added tax, turnover tax, service tax, stamp duty, tax on dividends and other special taxes and surcharges which are introduced on a temporary or permanent basis from time to time. Moreover, the central and state tax scheme in India is extensive and subject to change from time to time. The central or state government may in the future increase the corporate income tax it imposes. Any such future increases or amendments may affect the overall tax efficiency of companies operating in India and may result in significant additional taxes becoming payable. Additional tax exposure could adversely affect our business, cash flows and results of operations.

45. Fluctuation of the Rupee against foreign currencies may have an adverse effect on the price of the Equity Shares.

Any adverse movement in currency exchange rates during the time that it takes to undertake such conversion may reduce the net dividend to foreign investors. In addition, any adverse movement in currency exchange rates during a delay in repatriating outside India the proceeds from a sale of Equity Shares, for example, because of a delay in regulatory approvals that may be required for the sale of Equity Shares may reduce the proceeds received by Equity shareholders. For example, the exchange rate between the Rupee and the U.S. Dollar has fluctuated substantially in recent years and may continue to fluctuate substantially in the future, which may have an adverse effect on the trading price of our Equity Shares and returns on our Equity Shares, independent of our operating results.

46. Rights of shareholders under Indian laws may differ to those under the laws of other jurisdictions.

Indian laws and legal principles related to corporate procedures, directors' fiduciary duties and liabilities, and shareholders' rights may differ from those that would apply to a company in another jurisdiction. Shareholders' rights under Indian law, including in relation to class actions, may not be as extensive as shareholders' rights under the laws of other countries or jurisdictions. Investors may face challenges in asserting their rights as shareholder in an Indian company than as a shareholder of an entity in another jurisdiction.

Our Company proposes to deploy the entire Net Proceeds towards the Objects of the Issue during FY 2026–27. In the event that the Net Proceeds are not fully utilized within FY 2026–27 due to reasons beyond the control of the Company, the

unutilized portion shall be deployed in subsequent periods strictly in accordance with the Objects of the Issue and shall not be used for any purpose other than those stated herein.

The fund requirements, proposed deployment of funds and the intended use of the Net Proceeds set out above is based on our current business plan, internal management estimates, current circumstances of our business, prevailing market conditions and other commercial considerations. However, these fund requirements and proposed deployment of Net Proceeds have not been appraised by any bank or financial institution. We may have to revise our funding requirement on account of various factors, such as financial and market conditions, competition, price fluctuations, interest rate fluctuations and other external factors, which may not be within the control of our management. This may also entail rescheduling of the proposed deployment of the Net Proceeds at the discretion of our management, subject to compliance with the applicable laws. Further, in the event, the Net Proceeds are not utilized (in full or in part) for the objects of the issue during the period stated above due to any reason, including (i) the timing of completion of this Issue; (ii) market conditions outside the control of our Company; and (iii) any other economic, business and commercial considerations, the remaining Net Proceeds shall be utilized in subsequent periods as may be determined by our Company, in accordance with the applicable laws. Our Promoters, Mr. Anand Kumar Seethala and Mrs. Botcha Bhavani has brought in, from time to time, various amounts as unsecured loan, and vide their letters dated **July 01, 2026** had requested and confirmed to our Company that the unsecured loans aggregating to **₹ 399.13/- Lakhs** were outstanding from the Promoters as on **June 30, 2026** and have requested that out of the said outstanding amounts **₹ 398.85/- Lakhs** be adjusted towards subscription/application money for their respective entitlements in the present Rights Issue as part adjustment and for the balance subscription amount, the promoters will bring in the required amount. Accordingly, to the extent of such adjustment, no fresh proceeds will be received by the Company under the Rights Issue. However, the shares will be allotted against consideration already received by the Company in the form of unsecured loans in the past, as certified by the Statutory Auditor, M/s Dhanunjaya & Haranath, Chartered Accountants dated July 01, 2026 and for the balance subscription amount.

B. Funding the working capital requirements of our Company:

Our business is working capital intensive and our company funds a majority of our working capital requirement through internal accruals. For the expansion of our business and to enter new geographical areas, our company requires additional working capital which is based on our management estimations of the future business plan for the FY 2026-27. The working capital needs of our company, as assessed based on the internal workings of our Company is ₹ 4,151.29 Lakhs in FY 2026-27. We intend to meet our working capital requirements to the extent of ₹ 1,255.70 Lakhs from the Net Proceeds of this Issue and the balance will be met from borrowings and internal accruals at an appropriate time as per the requirement.

Justification for Holding Period:

Sundry Debtors	Historically the debtor holding period as on March 31, 2024 was 224 days which was increased to 378 days as on March 31, 2025 primarily due to slower realization from customers. Subsequently, the holding period improved to 281 days as on March 31, 2026 and further estimated to 244 days as on March 31, 2027, reflecting improved collection efforts and recovery of outstanding receivables. The receivable cycle continues to remain relatively longer due to the nature of the industry and customer profile served by the Company. The sundry debtors holding period depends on our gross turnover which is ultimate realisation from our customer, as our Company is engaged in the manufacturing and supply of Speed Limiting Devices (SLD), including Electronic Fuel Regulators (EFRT), Electronic Pedal Interfaces (EPI), and Vehicle Location Tracking Devices (VLTD), our Company's customer base primarily comprises distributors and dealers. The debtor holding period has remained elevated owing to the extended credit terms generally prevalent in the automobile safety and vehicle tracking equipment industry. Payments from distributors and dealers are often subject to internal verification procedures, installation certifications, testing requirements, regulatory compliance checks and multiple approval levels before release of payment. However, going forward we are estimating to maintain the Debtor holding period at levels of 244 days from Fiscal 2027 onwards as per our affordability to increase the top line as well to retain present & future customers as per the demand and market practice.
Inventories	As per the audited financial statements, inventory levels increased from ₹941.55 lakhs as on March 31, 2024 to ₹1,073.85 lakhs as on March 31, 2026. Inventory levels are maintained based on expected demand, production planning, and the need to ensure uninterrupted supply to customers. Historically, the inventory holding period has ranged between approximately 504 days, 308 days and 185 days during the last three financial years, with an average holding period of around 333 days. The relatively higher holding period reflects the nature of Our Company's operations, which require maintaining adequate stock of raw materials and finished goods to meet customer requirements in a timely manner, avoid supply disruptions, and manage fluctuations in demand. Going forward, our Company estimates an inventory holding period of approximately 180 days from Fiscal 2027 onwards. This estimation is based on anticipated growth in operations, expected increase in order volumes, and prevailing market conditions. Maintaining inventory at these levels will enable the Company to service a larger customer base efficiently, reduce lead times, and support revenue growth, which is expected to have a positive impact on both topline and profitability.
Sundry Creditors	As per the audited financial statements, sundry creditors stood at ₹368.97 lakhs as on March 31, 2024 and increased to ₹983.94 lakhs as on March 31, 2026. The increase in trade creditors was primarily attributable to higher procurement of raw materials, electronic components and other inputs required for the manufacturing of Speed Limiting Devices (SLD) and Vehicle Location Tracking Devices (VLTD), in line with the growth in the Company's business operations and sales volumes. Historically, the sundry creditor holding period has ranged from approximately 126 days, 192 days to 176 days during the last three financial years, with an average holding period of around 165 days. Although the absolute value of trade creditors increased during the period, the reduction in creditor holding period indicates that the growth in purchases and procurement activities outpaced the growth in creditor balances. The creditor holding period is influenced by factors such as supplier credit terms, procurement cycles, volume of purchases, industry practices and the Company's working capital management strategy. Going forward, our Company expects to maintain the creditor holding period at approximately 56 days as on March 31, 2027. This projection is based on

Such utilisation towards general corporate purposes shall be to drive our business growth, including, amongst other things, capital expenditure, meeting our working capital requirements, payment of principal, interest on borrowings, and, meeting of exigencies which our Company may face in its course of the business and any other purpose as permitted by applicable laws and as approved by our Board or a duly appointed committee thereof, subject to meeting regulatory requirements and obtaining necessary approvals/ consents, as applicable. Our management will have flexibility in utilizing the proceeds earmarked for general corporate purposes.

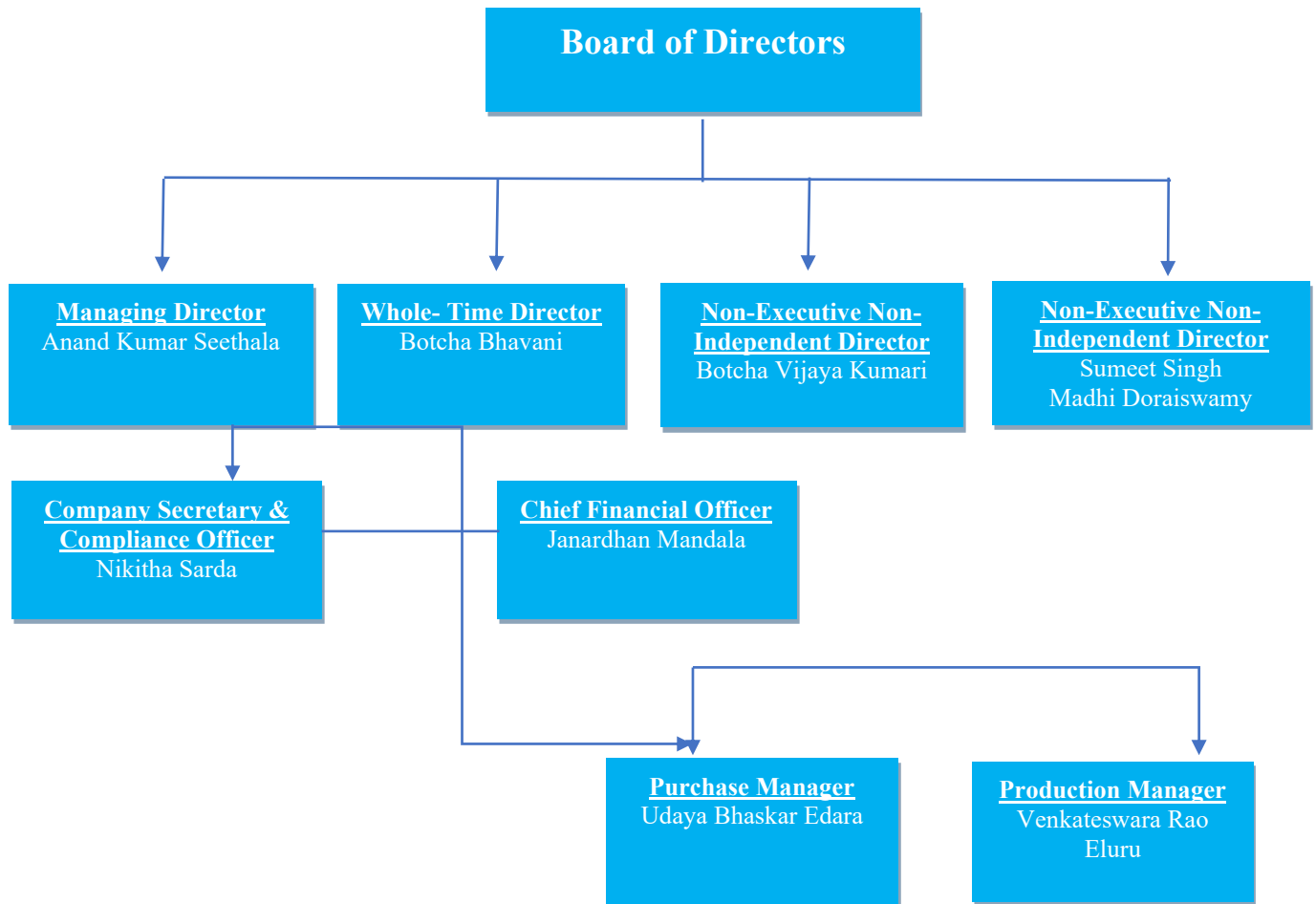

In case no corresponding record is available with the Depositories that match three parameters, (a) names of the Investors (including the order of names of joint holders), (b) DP ID, and (c) Client ID, then such Application Forms are liable to be rejected.
- (h) By signing the Application Forms, Investors would be deemed to have authorised the Depositories to provide, upon request, to the Registrar, the required Demographic Details as available on its records.

• ***Grounds for Technical Rejection***

- ***Procedure for Applications by certain categories of Investors***

Procedure for Applications by FPIs

In terms of applicable FEMA Rules and the SEBI FPI Regulations, investments by FPIs in the Equity Shares is subject to certain limits, i.e., the individual holding of an FPI (including its investor group (which means multiple entities registered as foreign portfolio investors and directly and indirectly having common ownership of more than 50% of common control)) shall be below 10% of our post-Issue Equity Share capital. In case the total holding of an FPI or investor group increases beyond 10% of the total paid-up Equity Share capital of our Company, on a fully diluted basis or 10% or more of the paid-up value of any series of debentures or preference shares or share warrants that may be issued by our Company, the total investment made by the FPI or investor group will be re-classified as FDI subject to the conditions as specified by SEBI and RBI in this regard. Further, the aggregate limit of all FPIs investments is up to the sectoral cap applicable to the sector in which our Company operates.

FPIs are permitted to participate in this Issue subject to compliance with conditions and restrictions which may be specified by the Government from time to time. FPIs who wish to participate in the Issue are advised to use the

Application Form for non-residents. Subject to compliance with all applicable Indian laws, rules, regulations, guidelines and approvals in terms of Regulation 21 of the SEBI FPI Regulations, an FPI may issue, subscribe to or otherwise deal in offshore derivative instruments (as defined under the SEBI FPI Regulations as any instrument, by whatever name called, which is issued overseas by an FPI against securities held by it that are listed or proposed to be listed on any recognised stock exchange in India, as its underlying) directly or indirectly, only in the event (i) such offshore derivative instruments are issued only to persons registered as Category I FPI under the SEBI FPI Regulations; (ii) such offshore derivative instruments are issued only to persons who are eligible for registration as Category I FPIs (where an entity has an investment manager who is from the Financial Action Task Force member country, the investment manager shall not be required to be registered as a Category I FPI); (iii) such offshore derivative instruments are issued after compliance with 'know your client' norms; and (iv) compliance with other conditions as may be prescribed by SEBI.

An FPI issuing offshore derivative instruments is also required to ensure that any transfer of offshore derivative instruments issued by or on its behalf, is carried out subject to inter alia the following conditions:

- (a) such offshore derivative instruments are transferred only to persons in accordance with the SEBI FPI Regulations; and
- (b) prior consent of the FPI is obtained for such transfer, except when the persons to whom the offshore derivative instruments are to be transferred to are pre – approved by the FPI.

Procedure for Applications by AIFs, FVCIs, VCFs and FDI route

The SEBI VCF Regulations and the SEBI FVCI Regulations prescribe, among other things, the investment restrictions on VCFs and FVCIs registered with SEBI. Further, the SEBI AIF Regulations prescribe, among other things, the investment restrictions on AIFs.

As per the SEBI VCF Regulations and SEBI FVCI Regulations, VCFs and FVCIs are not permitted to invest in listed companies pursuant to rights issues. Accordingly, applications by VCFs or FVCIs will not be accepted in this Issue. Further, venture capital funds registered as Category I AIFs, as defined in the SEBI AIF Regulations, are not permitted to invest in listed companies pursuant to rights issues. Accordingly, applications by venture capital funds registered as category I AIFs, as defined in the SEBI AIF Regulations, will not be accepted in this Issue. Other categories of AIFs are permitted to apply in this Issue subject to compliance with the SEBI AIF Regulations. Such AIFs having bank accounts with SCSBs that are providing ASBA in cities / centres where such AIFs are located are mandatorily required to make use of the ASBA facility. Otherwise, applications of such AIFs are liable for rejection.

Procedure for Applications by NRIs

Investments by NRIs are governed by the FEMA Rules. Applications will not be accepted from NRIs that are ineligible to participate in this Issue under applicable securities laws.

As per the FEMA Rules, an NRI or Overseas Citizen of India (“OCI”) may purchase or sell capital instruments of a listed Indian company on repatriation basis, on a recognised stock exchange in India, subject to the conditions, inter alia, that the total holding by any individual NRI or OCI will not exceed 5% of the total paid-up equity capital on a fully diluted basis or should not exceed 5% of the paid-up value of each series of debentures or preference shares or share warrants issued by an Indian company and the total holdings of all NRIs and OCIs put together will not exceed 10% of the total paid-up equity capital on a fully diluted basis or shall not exceed 10% of the paid-up value of each series of debentures or preference shares or share warrants. The aggregate ceiling of 10% may be raised to 24%, if a special resolution to that effect is passed by the general body of the Indian company.

Further, in accordance with press note 3 of 2020, the FDI Policy has been amended to state that all investments by entities incorporated in a country which shares land border with India or where the beneficial owner of an investment into India is situated in or is a citizen of any such country (“**Restricted Investors**”), will require prior approval of the Government of India. It is not clear from the press note whether or not an issue of the Rights Equity Shares to Restricted Investors will also require prior approval of the Government of India and each Investor should seek independent legal advice about its ability to participate in the Issue. In the event such prior approval has been obtained, the Investor shall intimate our Company and the Registrar about such approval within the Issue Period.

Procedure for Applications by Mutual Funds

A separate application can be made in respect of each scheme of an Indian mutual fund registered with SEBI and such applications shall not be treated as multiple applications. The applications made by asset management companies or

custodians of a mutual fund should clearly indicate the name of the concerned scheme for which the application is being made.

No Mutual Fund scheme shall invest more than 10% of its net asset value in equity shares or equity related instruments of any single company provided that the limit of 10% shall not be applicable for investments in case of index funds or exchange traded funded or sector or industry specific schemes. No Mutual Fund under all its schemes should own more than 10% of any company's paid-up share capital carrying voting rights.

Procedure for Applications by Systemically Important Non-Banking Financial Companies ("NBFC-SI")

In case of an application made by NBFC-SI registered with RBI, (a) the certificate of registration issued by RBI under Section 45IA of RBI Act, 1934 and (b) net worth certificate from its statutory auditors or any independent chartered accountant based on the last audited financial statements is required to be attached to the application.

Last date for Application

The last date for submission of the duly filled in the Application Form or a plain paper Application is Friday, September 25, 2026, i.e., Issue Closing Date. Our Board or any committee thereof may extend the said date for such period as it may determine from time to time, subject to the Issue Period not exceeding 30 days from the Issue Opening Date (inclusive of the Issue Opening Date).

If the Application Form is not submitted with an SCSB, uploaded with the Stock Exchange and the Application Money is not blocked with the SCSB, on or before the Issue Closing Date or such date as may be extended by our Board or any committee thereof, the invitation to offer contained in this Letter of Offer shall be deemed to have been declined and our Board or any committee thereof shall be at liberty to dispose of the Equity Shares hereby offered, as set out in the section entitled "***Basis of Allotment***" on page 79.

Please note that on the Issue Closing Date, Applications through ASBA process will be uploaded until 5.00 p.m. (Indian Standard Time) or such extended time as permitted by the Stock Exchange.

Please ensure that the Application Form and necessary details are filled in. In place of Application number, Investors can mention the reference number of the e-mail received from Registrar informing about their Rights Entitlement or last eight digits of the demat account. Alternatively, SCSBs may mention their internal reference number in place of application number.

Withdrawal of Application

An Investor who has applied in this Issue may withdraw their Application at any time during Issue Period by approaching the SCSB where application is submitted. However, no Investor applying through ASBA facility may withdraw their Application post the Issue Closing Date. In case of Specific Investor in whose favour Promoter and Promoter Group have renounced their Rights Entitlement and the Specific Investors have made an application for subscribing to the Rights Entitlement, then no withdrawal of such application will be allowed.

Disposal of Application and Application Money

No acknowledgment will be issued for the Application Money received by our Company. However, the Designated Branches of the SCSBs receiving the Application Form will acknowledge its receipt by stamping and returning the acknowledgment slip at the bottom of each Application Form.

Our Board or a committee thereof reserves its full, unqualified and absolute right to accept or reject any Application, in whole or in part, and in either case without assigning any reason thereto.

Wherever an application is rejected in part, the balance of Application Money, if any, after adjusting any money due on Rights Equity Shares Allotted, will be refunded / unblocked in the respective bank accounts from which Application Money was received / ASBA Accounts of the Investor within one Working Day from the Issue Closing Date. In this regard, our Company has made necessary arrangements with NSDL and CDSL for crediting of the Rights Entitlements to the demat accounts of the Eligible Equity Shareholders in a dematerialized form. A separate ISIN for the Rights Entitlements has also been generated which is ISIN: INE0M8920010 . The said ISIN shall remain frozen (for debit) until the Issue Opening Date. The said ISIN shall be suspended for transfer by the Depositories post the Issue Closing Date.

Additionally, our Company will submit the details of the total Rights Entitlements credited to the demat accounts of the Eligible Equity Shareholders and the Demat Suspense Account to the Stock Exchange after completing the corporate action. - ***Renunciation of Rights Entitlements***

(a) On Market Renunciation

The On Market Renunciation shall take place only during the Renunciation Period for On Market Renunciation, i.e., from Monday, August 31, 2026 to Tuesday, September 22, 2026 (both days inclusive).

The Investors holding the Rights Entitlements who desire to sell their Rights Entitlements will have to do so through their registered stock-brokers by quoting the RE ISIN: INE0M8920010 and indicating the details of the Rights Entitlements they intend to trade. The Investors can place order for sale of Rights Entitlements only to the extent of Rights Entitlements available in their demat account.

The Investors can transfer Rights Entitlements only to the extent of Rights Entitlements available in their demat account.

Please note that as per SEBI Circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2025/31 dated March 11, 2025, last day for off-market transfer of REs shall be one working day prior to the Issue closing day.

VI. MODE OF PAYMENT

• **Fractional Entitlements**

- ***Nomination***

Further, where the fraud involves an amount less than ₹10 Lakhs or 1% of the turnover of the company, whichever is lower, and does not involve public interest, any person guilty of such fraud shall be punishable with imprisonment for a term which may extend to five years or with fine which may extend to ₹50 Lakhs or with both.

There are two routes through which foreign investors may invest in India. One is the “automatic route”, where no government approval is required under Indian foreign exchange laws to make an investment as long as it is within prescribed thresholds for the relevant sector. The other route is the “government route”, where an approval is required under foreign exchange laws from the relevant industry regulator, prior to the investment.

Foreign investment in Indian securities is regulated through the Industrial Policy, 1991, of the Government of India and FEMA.
